

## **Important Customer Info**

The AccountNow Prepaid Card Account program is ending, and all AccountNow Prepaid Visa® Card Accounts and AccountNow Prepaid Mastercard® Card Accounts will be closed on **April 19, 2023**.

What you need to know:

- Your AccountNow Prepaid Card Account will not accept deposits after March 28, 2023. If you receive direct deposit(s) to your AccountNow Prepaid Card account, you will need to update your direct deposit account information with your employer or government benefits provider as soon as possible. All deposits, including cash deposits attempted after this date will be rejected.
- Any automatic payments you have set up with your AccountNow Prepaid Card Account will not be processed after April 18, 2023. You will need to contact the biller(s) as soon as possible to provide another means of payment. Any automatic payment requests received after this date will be declined and the biller will not be paid.
- You will have through April 18, 2023, to spend down the balance on your account. You should use your prepaid card to make purchases and ATM withdrawals until your balance reaches zero. Any remaining funds on your AccountNow Prepaid Card Account after this date will be mailed to your address on file within 45 days. Please note, refunds under \$1.00 may not be processed.

You can still <u>log in</u> to your AccountNow Prepaid Card Account after April 19, 2023, to access your statements. All other account services will not be available after this date. For questions about your AccountNow Prepaid Card Account please call (866) 925-2036.

Additional criteria may apply which can affect your eligibility and your overdraft coverage. Overdrafts are paid at our discretion. Overdraft fees may cause your account to be overdrawn by an amount that is greater than your overdraft coverage. A \$15 fee may apply to each eligible purchase transaction that brings your account negative. Balance must be brought to at least \$0 within 24 hours of authorization of the first transaction that overdraws your account to avoid a fee. Learn more.
- 3 Interest paid quarterly on the average daily balance of savings during the quarter up to a \$5,000 balance and if the account is in good standing. Fees on your primary deposit account may reduce earnings on your savings account. 4.50% Annual Percentage Yield (APY) as of January 2023. APY may change before or after you open an account. - 4 Early direct deposit availability depends on payor type, timing, payment instructions, and bank fraud prevention measures. As such, early direct deposit availability may vary from pay period to pay period. The name and Social Security number on file with your employer or benefits provider must match your GO2bank account to prevent fraud restrictions on the account.
